From October 2019, the diversity data rules have been achievements of the charity changed to treat sexual orientation data like other data. during the year In February 2019, FreeBar launched its website in time for LGBT History month In March 2019, FreeBar held its second 'best practice' event, which was well attended and featured speakers from the Judicial Appointments Commission, two barristers and two chambers staff. At this event a student said he was unable to tell which chambers were 'LGBT friendly' and it would help to be able to see what was on offer. This is where the idea of the charter came about. In October 2019, FreeBar was represented for the first time at the LBGTLeaders conference for students. Members spoke on behalf of FreeBar at various Bar related events: the Judicial Diversity Forum (about attracting LGBT people to apply for judicial appointments); the annual Institute of Barristers' Clerks Conference; the LBGTLeaders conference for students. Various social events were held, including a joint ComBar (Commercial Bar Association) TecBar (Technology and Construction Bar Association) and FreeBar event at 39 Essex Chambers in May The FreeBar Charter was conceived, drafted and a consultation launched.
